Mayor Bourne introduced Ordinance, O-23-07, compensation for the mayor, and Ordinance, O-23-08, compensation for the city council. Council Member Howell commented that he would like to see the city council at \$100 per month. Council Member Losee commented that he agreed. Council Member Allen stated she didn't even know she received any compensation when she volunteered to be on the city council and she agreed on the \$100. Council Member Atkinson stated she feels it should be \$150 a month. Council Member Nelson commented that she agreed on the \$100 per month and that she wanted to see the mayors increase more than the \$50.00. A discussion ensued.

Council Member Atkinson made a motion that we pass Ordinance, O-23-07, for the compensation for our elected official of the mayor at \$600 a month. A second was made by Council Member Nelson. The roll call vote results are as follows:

At this point in the meeting Council Members Losee and Howell left the meeting.

Mayor Bourne stated the second item under old business was a discussion and vote on amending the sewer plant engineering change order. Council Member Nelson stated that basically, we are changing from an hourly rate to a lump sum per the USDA.

Council Member Nelson made a motion that we approve the redo of the engineering change order #4 for the dollar amount of \$22,000 changing it from an hourly of \$15,000 to a lump sum of \$22,000. A second was made by Council Member Allen with all council members present voting in favor of the motion.

Mayor Bourne stated under new business was a discussion and vote on the election contract. Council Member Nelson asked if this was just a formality, there are no other options and you get what you get. Sharlet answered yes because she wouldn't want to do it without the county. She said the price could change based on the amount of registered voters.

Council Member Nelson made a motion to approve the contract for election services. A second was made by Council Member Allen with all council members present voting in favor of the motion.

Mayor Bourne asked if there were any financial questions. There were none.

Council Member Nelson made a motion to approve the coding for accounts payable and payroll and utility account adjustments. A second was made by Council Member Atkinson with all council members present voting in favor of the motion.

Mayor Bourne asked if there were any requests for future agenda items. Council Member Nelson requested that we put the roof back on there.

Council Member Atkinson made a motion to adjourn at 8:38 p.m. A second was made by Council Member Nelson with all council members present voting in favor of the motion.
