**BID SUBMITTAL:** Sealed bids will be received at the office of the City Recorder, of Garland City, until 4:15 PM., on Tuesday, April 16<sup>th</sup>, 2024; and then at said office publicly opened and read aloud.

**DESCRIPTION OF BID WORK:** The work includes furnishing all labor, tools, materials, equipment, transportation, and services required for construction of the above project; consisting of the following items of work: mobilization; obtaining all bonds and insurance, removal of existing asphalt; excavating approximately 15,000 cubic yards of material to build a road with 15-inch thick pitrun, 10-inches of roadbase and 4-inch of asphalt; removal of sidewalk and other concrete flatwork; removal of miscellaneous landscaping and trees; installation of approximately 7,750 feet of curb and gutter; 5,600 feet of sidewalk; furnishing and installing approximately 1,560 feet of 24-inch class III rcp storm water pipe; 160 feet of 15-inch class III rcp storm water pipe; storm water manholes; combo boxes and catch basins; removal and replacement of fire hydrants; relocate water meters and replace water service laterals; furnish and install approximately 13,680 ton of pit run, 10,500 ton roadbase and 4,000 tons of bituminous asphalt and all appurtenant work in accordance with the Drawings and Specifications prepared by the Engineer, CEC, Civil Engineering Consultants, PLLC.

**ESTIMATE:** The Engineer's Estimate of Cost for the total project is \$2,750,000.

**BID SECURITY:** All bids must be accompanied by a Bid Bond, Certified Check or Cashier's Check in the amount of 5% of the maximum bid price, drawn payable to the order of Owner noted herein.

**BID GUARANTEE:** All Bids submitted shall be in conformance with the Instructions to Bidders and shall be guaranteed by the Bidder for a period of sixty (60) days from the date of Bid Opening.

**OWNER'S RIGHTS RESERVED:** The Owner hereby reserves the right to reject any or all bids presented, to waive any informality in a bid, and to make award or refuse in the interest of the Owner.

**PROJECT CONTRACT TIME:** All proposed work contained in the contract documents shall be completed by 31<sup>st</sup> October 2024.
