Those who have recently traveled on West Factory Street may have noticed that the Lakeshore Learning project is coming along. ARCO, the construction company, has started standing walls up! This progress has not been made without sacrifice from many of our community members, especially those living on 300 W and West Factory Street. We have heard many concerns from residents in this area about early morning (really early!) bright lights and construction noises including cement trucks. We have reached out to ARCO and shared these concerns. In response to our conversations, ARCO has sent a letter with a construction update and progress report. This letter is included in this newsletter.

In summary, it states that early morning work hours are essential for this project based on the following needs:

- risk of concrete hardening if trucks are delayed in daytime traffic.
- since large volumes of concrete are needed, (and so many trucks delivering it) delivery later in the day would impact local traffic.
- concrete suppliers would be unable to provide concrete services to other customers if they were delivering concrete to this project during the day. This would impact other projects in the area, and/or delay this project longer.
- by following the current concrete delivery timing, the project can minimize the total time of resident inconvenience.

In the short term, this solution is miserable. Long term, we are expecting this to be over within the next few months and things will be able to get back to normal. Lakeshore Learning and ARCO are wonderful community partners and will continue to be long into the future. They are truly doing their best to complete this project safely and quickly while providing quality services.

As you will notice in the included letter, ARCO has included contact information for anyone who continues to have questions or concerns.

#### Garden Share Program - Grow an extra row!

We have joined forces with Waste Less Solutions, an organization dedicated to reducing food waste and ensuring that surplus food reaches those in need. To help locally with food needs we will have a cooler placed at the City office for local community members to donate excess produce from their gardens. RE: Lakeshore Learning Distribution Center Construction Progress Update

Dear Garland residents,

At ARCO, our core purpose is to provide a construction process which is both enjoyable and beneficial for all parties involved. We recognize that this purpose extends to our neighbors in the Garland community during our construction efforts to deliver the future distribution center for Lakeshore Learning at 415 W Factory Street.

We appreciate the goodwill shown to us by the residents of Garland and intend to return this sentiment by providing a construction experience that is timely, clean, safe, and minimizes the disturbance to residents. In an effort to be good neighbors, we would like to provide a construction progress update and address some frequently asked questions/concerns:

### Construction Progress Update:

Winter weather has slowed the pace of construction, and with spring approaching residents should expect an increase in construction activity. As you may have noticed, some of the exterior walls of the building facing Factory Street are now standing with structural steel being installed. On the opposite side of the building, mass grading, foundations, floor slabs and construction of walls are ongoing. A high volume of exterior construction activity can be expected through fall of 2024, and construction is anticipated to be completed by the first quarter of 2025.

#### Frequently Asked Questions:

1. Q: Why is so much construction activity taking place at night and in the early hours of the morning?

**A:** Large-scale concrete work for the floor slabs and exterior building walls requires placement of concrete during the night and early morning for several reasons:

- There is a high risk of concrete curing (hardening) inside the delivery truck before it can be poured if trucks were to be delayed by day-time traffic.
- Large-scale concrete work necessitates a high-volume of concrete delivery trucks. A
  high-volume of concrete trucks on the road during peak day-time traffic hours would
  negatively affect the commute times of residents.
- Local concrete suppliers have other customers in the community who need day-time service. Due to the high volume of concrete required for this project, suppliers are unable to serve other customers concurrently.
- Working around the clock enables construction to be completed as quickly as possible minimizing the total time period the local community experiences construction related disturbance.

# 2. Q: What is the schedule for night-time work to take place?

**A:** Concrete construction is a weather-dependent process which does not allow night-time placements to follow a set schedule on the same days each week. Under good weather conditions, night-time concrete placements should be expected for 3-4 nights per week. Typically, these placements begin around midnight (12:00am) and continue until the following morning around 7:00am.

# 3. Q: When will night-time work be completed?

**A:** The overall completion date of night-time concrete placements remains weather dependent, however the high-frequency night-time work is anticipated to continue through July of 2024. Later phases of the construction process will require isolated periods of night-time work, but this will be far less frequent. Day-time construction traffic will not be influenced by the conclusion of night-time work and will remain somewhat consistent throughout the duration of the project.
